The proposed project is for a Rapid Re-housing program in Saginaw County for victims of domestic violence and sexual assault. The households become homeless due to safety issues in their former residence. The project will house 6 families for six months, with a total of 12 families assisted by this program during the term of the grant. Each family will be provided with rent and utilities assistance based on income, intensive case management (job skills workshops, benefit eligibility review/applications, counseling and legal advocacy), childcare and transportation assistance. At any given time we turn away 2 to 4 families per day due to lack of shelter/housing space. The families we serve have various housing needs ranging from very short term emergency shelter, transitional housing to permanent supportive housing. The Rapid Re-housing program meets the needs for our families who need more time than an emergency shelter stay but do not need a 2 year transitional housing program to be able to maintain permanent housing. We have been providing Rapid Re-housing programming since June of 2010. We expect no delays in service delivery if our grant is renewed.


