### 1. Provide a description that addresses the entire scope of the proposed project.

The Underground Railroad (URR) has provided transitional housing programming since 1999. URR proposes to provide transitional housing for survivors of domestic and sexual violence who are experiencing homelessness. Our project will provide up to 24 months of supportive housing for 14 households. The project will also provide intensive case management for an additional 15 households in transitional housing units, a licensed childcare center for families in our programs, transportation assistance, counseling, mental health services and case management services for the children in the project to ensure enrollment and success in school. Six months of supportive case management will be provided after housing assistance has ended. Our projected outcomes are income stability, self-determination and residential stability. We are actively involved with and partner with our community's mainstream programs and non-profits to ensure the best use of resources and enable easy access to services for our clients. Our local CoC supports our program because housing services for victims of domestic violence are key to solving our community's homeless problem. We anticipate no delays in service delivery if this project is renewed.
