The Underground Railroad (URR) proposes to provide transitional housing for homeless victims of domestic and sexual violence. Our project will provide 24 months of supportive housing for ten women and their children. In addition to the housing assistance project participants will be provided intensive case management, counseling, childcare, mental health services, transportation assistance and legal advocacy. Supportive case management will be provided to families for up to six months after the housing assistance has ended. Our projected outcomes are Income Stability, Self-Determination and Residential Stability. We are actively involved with and partner with our communities mainstream programs and non-profits to ensure the best use of resources and enable easy access to services for our clients. URR is a key provider of homeless assistance services in Saginaw County and therefore is supported by our local COC as part our communities plan to end homelessness.


