Mustard seed Shelter personnel provide the following:

- Monthly visits/appointments
- Assistance with navigation of mainstream services
- Co-pays for doctor appointments and prescriptions
- Assistance with completion of GED and other educational pursuits
- Assistance with finding housing, moving and furniture and household goods
- Assist women with children to access appropriate services for children
- other services as needed by the families

The purpose of this program is to assist women and their families become successful at independent living and emotionally/physically stable long-term housing so they are able to stop the cycle of moving through the homeless shelter system and couch surfing which affects their and their children's emotional and at times physical health.
