The Transitional Housing program provides 8 private/semi-private rooms where residents can reside for up to two years. This is the second step in training or 'transitioning' men back into permanent housing. This program is designed for men who have some form of income (employment, disability, or other earned income) and require that they pay up to 30% of their income as rent. Transitional Housing allows the residents to save money towards housing and to improve their potential to obtain gainful employment. During this course of time, residents are expected to redirect their values, goals, and vision. Residents are required to attend mandatory life skills and/or 12 step classes every week as well as any education/employment classes which are central factors during their stay in the program. RCO will provide the supportive services needed to enhance the resident's quality of life during this phase. Case Management, in collaboration with the other service providers, will work closely to address the needs of each resident.
