Homeless youth and homeless teenage parents will be provided with rent, security deposit and utility assistance. The agency has vast experience with delivering rapid re-housing services. The agency began delivering these services in 2009 with HPRP and continues to provide these services in partnership with the CoC Lead Agency. We are familiar with HUD requirements, paperwork, data entry requirements, and processes. Rental assistance will be mid to long term. Strength-based case management will be provided minimally on a once a month basis.
