Teen Parent Services Transitional Housing/St. Rita's is a 10 bed transitional housing program for homeless teenage parents 17 - 20 years of age and their young children. The program provides comprehensive supportive services that are designed to move homeless teenage parent families to self-sufficiency and permanent housing. Teenage parents are connected to education, job training, employment and preventive health care. A strong emphasis is placed on parenting and early childhood development education. The program is an Early Head Start service provider and uses evidenced-based curriculum (Parents as Teachers) and screening tools including Ages and Stages Developmental Questionnaire. The teen parents also participate in Trauma Focused Cognitive Behavioral Therapy and substance abuse therapy (Seven Challenges). Referrals are made to our CoC Housing Resource Specialist for assistance in signing up for Housing Choice Vouchers and Section 8 vouchers. Teen parents also participate in life skills classes. The teen parents are also provided with transportation, food, personal care items and household items.


