Underground Railroad has been successfully providing Transitional Housing services in Saginaw since 1999, RRH since 2012 and providing services to victims of domestic violence since 1977. We are active participants in our local CoC and have the agency capacity and experience to implement this new project quickly and effectively. Underground Railroad is the only agency in Saginaw County providing shelter and supportive services to victims of domestic violence, sexual assault, stalking and human trafficking. Underground Railroad currently provides shelter, counseling, individual advocacy, transitional housing, civil legal attorney services, PPO assistance, supervised visitation and court advocacy to these victims, as well as victims of sexual assault, stalking and human trafficking. The agency employs 54 staff members and manages an average of 550 volunteers each year. Underground Railroad currently offers the following supportive services to TSH and RRH clients 1) Advocacy/Case management (including safety planning), 2) Counseling, 3) Weekly TSH support groups, 4) URR licensed childcare center, 5) Subsidized housing, 6) Survivor driven Individualized Service Plans with goals and action steps, 7) Referral support within URR and the community, 8) Individual Specific Assistance: cell phone, transportation, i.e. bus tokens, help with utilities, security deposit, rent; URR vouchers to be redeemed for goods at our resale store, 9) Monthly food boxes, 10) After business hours on-call response, 11) Assistance with furnishing housing unit, 12) Advocacy for long term permanent housing and follow-up services, and 13) Supervised visitation/exchange (through court order only), and Court support services. We leverage volunteers and local matching funds every year. We have strong agency policies and procedures in place including strong accounting controls. We are subject to an independent comprehensive quality assurance audit conducted by the Michigan Domestic and Sexual Violence Treatment Board every five years, our last audit was conducted in August of 2017 and we scored 100% with no negative findings. We are also subject to a yearly independent financial audit and have had no significant findings.

### **2. Describe your organization’s (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.**

We currently manage 17 state and federal grants including 4 HUD grants and 2 additional transitional housing grants totaling approximately 2.3 million dollars. Additionally, we leverage an average of 15-17 local foundation grants every year which totaled over \$300,000 last year. Underground Railroad has been providing housing assistance since 1999 and includes Rapid Rehousing, Permanent Supportive Housing and Transitional Housing from a variety of funding sources including HUD.

**3. Describe your organization’s (and subrecipient(s) if applicable) financial management structure.**

The Underground Railroad is managed by a Board of Directors consisting of a minimum of seven and a maximum of seventeen director, including the Chief Executive Officer. The main function of the Board is to develop and monitor policies, making the CEO responsible for delegation and accountability. The BOD’s Finance Committee meets monthly and is responsible to oversee the allocation and accounting of capital resources and to inform the Board about the condition and status of such. Additionally, the committee monitors all financial accounting systems, reviews monthly financial statements, audit reports, insurance policies and other financial documents. In addition, the Finance committee reviews and monitors all monitoring reports and findings from grantor agencies, and reviews the Accounting Procedures Manual in its entirety once every three years. The Finance committee, CEO and Accounting Manager continually monitor financial activity. When results are inconsistent with expectations, an evaluation is performed by program managers and the CEO to determine if changes need to be made. When financial or internal control issues are brought to the CEO’s attention, an analysis is made of the associated risks to determine if changes need to be made. The CEO provides information to the Finance committee when the resolution is a significant change from the current policy.

**1. Provide a description that addresses the entire scope of the proposed project.**

This project will allow Underground Railroad (URR) & the Saginaw County (SC) CoC optimize the SC CES so that survivors of DV/SA experiencing homelessness have access to services, the system is easier to navigate & households move quickly to permanent housing. The target population for this project are survivors of DV&SA (Survivors) as defined in CoC Interim Rule at 24CFR§578.3(4). The SC CoC has a “No wrong door” CE system & survivors regularly enter the CES via non-DV/SA organizations. Our goal is to ensure that survivors are met with staff who have been well-trained on trauma-informed assessment & intake practices, safety planning & DV/SA, regardless of which access point they utilize. In Saginaw only 5% of clients at non-DV shelters identified as actively fleeing DV & only 15% at a non-DV shelter identified as having an incident of DV/SA in their past. Given that DV/SA is the leading cause of homelessness for women & children we believe that survivors are being under-identified when presenting at non-DV shelters in SC. The project will implement policies, procedures & practices that better equip the CoC’s CE System to best identify & meet the needs of survivors. URR currently serves as an access & referral point for survivors entering the CES in Saginaw County. A full-time DVCE Coordinator (DVC) will work with the CoC to conduct an annual assessment of service needs of survivors as well as current policies & practices related to survivors. This will result in recommendations for strategies as well as new policies, procedures & practices that will better equip the CoC’s CES & CoC providers to meet the needs of survivors using trauma-informed, victim-centered approaches. This will reduce re-traumatization & ensure that survivors rights, voices & perspectives are incorporated when developing & implementing policies & practices that impact victims. The DVC will provide regular training on DV/SA, safety planning & trauma-informed intake & assessment practices to staff at all CoC access points. The DVC will make this training sustainable & ensure new staff are trained quickly. Training is essential to ensuring that all CoC projects serve survivors with sensitivity, assist them with making informed choices & in a manner that will increase the clients’ safety & security. The VI-SPDAT is currently used to assess at access points. This tool is not trauma-informed or adequate for assessing for DV/SA & often DV is not disclosed until much later if ever. Many victims of DV/SA experience fear & shame & may not disclose for these & other reasons. The DVC will work with the CoC to identify trauma-informed assessment options that could be utilized at access points to increase the likelihood of survivors self-identifying at intake. The DVC will conduct outreach to advertise the CE system to the community to help survivors who may need services to access them. The DVC will serve as a case manager to get any survivors referred from mainstream sources connected to the CE system.

- Direct street outreach, informational brochures at service sites, soup kitchens

and public locations, announcements at community events and at collaborative body meetings, schools, hospitals, clinics and other mainstream service providers. Our marketing is targeted and makes access points and services accessible to all groups regardless of sex, gender identity, age, color, creed, disability status, family status, marital status, sexual orientation, ethnicity, national origin or religion.

- To overcome barriers and increase communication with clients who are least likely to request assistance, we have implemented toll free and 2-1-1 access, TTYD capabilities, braille pamphlets/information, pictographs, multi-lingual/sign language interpreters, transportation for cognitive/physical limitations, free phones through local Salvation Army and internet access through public libraries, shelters, DHHS, Facebook and Twitter accounts. All members have individual websites and information on programs available, and can also be found on the CoC website.

- The DV Coordinator will outreach to all homeless service providers as well as organizations such as The Disability Network, Council on Aging, and others organizations who may serve individuals who are experiencing homelessness and have a history of domestic violence. These individuals may not know or have the ability to contact Underground Railroad, Inc. through the “No Wrong Door” approach. The DV Coordinator will have the ability to meet them where they are at to ensure they are aware and have access to services.

- The DV Coordinator will work with the Underserved Populations Advocate when needed with regards to Spanish-speaking households. The Underserved Populations Advocate is fluent in Spanish.

- Following an initial triage to determine literally homeless or fleeing DV and/or family violence, shelters will proceed with the standardized assessment, VI-SPDAT, (DV provider uses a comparable assessment) for housing placement and begin to coordinate with available community based resources
- Initial screening at all access points allow for immediate linkage to the appropriate subpopulation access point. All clients can easily access the CEP whether in person, by phone, through 2-1-1 or some other method 24 hours/day 7 days/week. Emergency shelter services are available 24/7 and all CEP physical locations are accessible to individuals with disabilities including wheelchair access.
- Clients are prioritized based on their VI-SPDAT score, length of time homeless, chronic homeless, family’s w/children homeless, health/behavioral challenges, substance disorders, youth and DV at high risk (DV Housing Assessment Tool for DV clients).
- The DV Coordinator will work to ensure that individuals who have experienced DV know and have the opportunity to work the DV provider to receive services.
